Agenda No 02: Amendment in 3 year LL.B and 5 year B.A.LL.B Course evaluation scheme.

Dr Dinesh Babu; Dean of Faculty of Law, presented 3 Year LL.B and 5 year B.A.LL.B syllabus for amendment in evaluation system. Previously the evaluation system comprised of 100 marks for theory only, but now the revised evaluation will have 70 marks for theory and 30 marks for internal for both the courses, 3 year LL.B and 5 year B.A.LL.B from the academe session 2021-22.

Dr Dinesh Babu apprised the members that as per the UGC letter no. F 8-34/2015(CPP-1/PU) dated 19.10.2020, University has been granted permission to run LL.M course. The external subject expert suggested preferring Corporate Law, Intellectual Property Law (IPR), and Alternative Dispute Law (ADR) in LL.M curriculum. Member also suggested that practical aspects should be given preference in LL.M course. Member suggested that evaluation scheme will have 60 marks for theory and 40 marks for internal in LL.M curriculum.
