Every student has to select a topic for research dully approved by the Head of the Department and take up the research work during the course of fourth semester. The topic must be choosen at the end of the third semester and the approval would be communicated at the beginning of the fourth semester. The research must be carried out under the supervision of a supervisor, who has been experienced and qualified to be a professor/ Associate Professor/ Assistant professor of respective department.

The dissertation must be of at least 100 pages typed on one side of the paper with 1.5 spaces. Methodology prescribed must be strictly followed in regard to citation, bibliography, chapter index etc. It must be the original work of candidate. The dissertation must be submitted at least 15 days before the commencement of the final semester examination.
