Eligibility Conditions:-

A 1-Year/2-Semester Master's Degree programme after a 4-year /8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualification declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate in the subject concerned or in and allied subject OR its equivalent grade in a point scale wherever grading system is followed OR equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by and authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institutions.

M.Phil. degree or a recognized equivalent degree beyond master's degree level with at least 55% marks or equivalent grade in the grading system and master's degree with 50% marks in aggregate in the subject concerned or an allied subject.

Candidates who have cleared the M.Phil. Course work with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-Point scale (or an equivalent grade in a point scale wherever grading system is followed) and successfully completing the M.Phil. degree shall be eligible to proceed to do research work leading to the Ph.D. Degree in the same institution in an integrated programme.

A relaxation of 5% of marks 55% to 50% or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC /non-creamy layer /differently -abled and other categories of candidates as per the decision of the commission from time to time.

A person whose M.Phil. Dissertation has been evaluated and the viva-voce is pending may be admitted to the Ph.D. Programme.

Admission Process:-

The University shall admit Ph.D. Scholars through National Eligibility Test(NET) score and interview, or Entrance test conducted at the level of University and interview.
