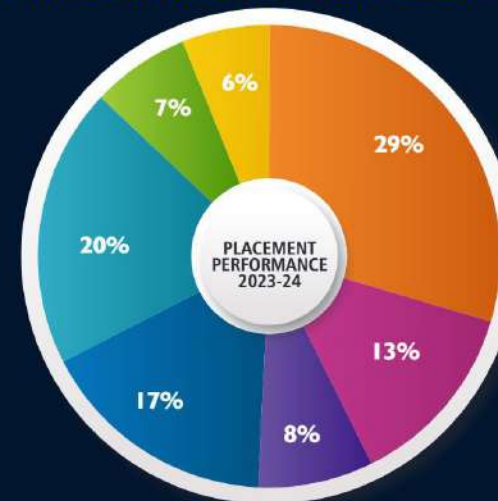

Ragging
Alcohol, Smoking, Gambling
Misconduct, Hooliganism, Indiscipline
Possession or use of firearms or any lethal weapon
Possession or use of addictive or hallucinogenic drugs in the campus
Possession or use of alcoholic beverages or delinquency under the influence of alcohol

Students found guilty of such act by the way of indulging in or outside the premises of the University shall be liable to punishment as per the guidelines given by UGC in the light of direction of Hon'ble Supreme Court depending upon the nature and gravity of the offences established by Anti Ragging Committee of the University.

The punishment for those found guilty of the ragging at the University level shall be any one or any combination of the following:

1. Suspension from attending classes and academic privileges.
2. Withholding/ withdrawing scholarship/ fellowship and other benefits
3. Debarring from appearing in any test/ examination or other evaluation process
4. Withholding Results
5. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
6. Suspension/expulsion from the hostel
7. Cancellation of admission
8. Rustication from the institution for period ranging from 1 to 4 semesters
9. Fine ranging from Rs. 25,000/- and Rs. 1 Lakh
10. Collective Punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment

### STUDENT DISCIPLINE:-

Student enrolled in the University must recognize their responsibilities towards the faculty, Office staff and fellow students by maintaining appropriate standards of conduct will attract disciplinary action.

The University believes that duty, decorum and discipline are the hallmarks of a good student. Students with such qualities alone can prove to be productive manpower with appreciable value system. Therefore erring students would be subject to certain disciplinary code. The following acts would be deemed to be acts of indiscipline: any overt or covert act leading to ragging, eve teasing disruption of class room activities, disturbing the studies of other students or marring the operations of the University, its educational activities or harming the health, safety of staff or students or damaging the property, possession of any intoxicants, illicit drugs or weapons in the University campus, misconduct during examination, production of false information or documents for admission purpose and the failure to returned loaned materials or settle debts with the P.K. University of Studies.

### RULES & REGULATIONS:-

- If an applicant is found not eligible for admission on verification of the document's at any stage or otherwise, eligibility shall stand cancelled. If such instances go undetected during the admission process but are detected in subsequent semester/year, such disqualification will take place with retrospective effect. In such a case, the applicant shall have no claim whatsoever against the P.K.University.
- All the students shall be required to produce their original certificate of the last examination passed for verification as and when asked for. Since all the admission to University are provisional and are likely to be cancelled if the original certificates are found fake and fraudulent. Such students will not be awarded a degree certificate even after completion of the course. The University reserves the right to withdraw a degree certificate from the student whose educational documents are not found genuine or true.
- The Degree/Diploma/Certificates will be awarded to the students only if he/she acquires pass grade in all the semesters within the maximum duration of the course.
- In case a student does not clear all the examination in the maximum duration as mentioned in the course details, he/she will not be awarded a Degree / Diploma/ Certificate and no fee shall be refunded such that case.
- The student can discontinue his/her studies anytime during the year but the fees paid by him/her will not be refunded in any circumstances.
- It is the wholesome discretion of P.K. UNIVERSITY to upgrade or modify the syllabus or content of the course without prior intimation to student.
- Fees is non-refundable neither adjustable.



## Admission Guidelines for Candidates

1. It is mandatory to bring the original documents along with the photocopies of all the necessary documents at the time of admission. If the candidate takes admission through online mode or is unable to produce the original documents at the time of admission, then the candidate should bring all his original documents within one month. Document verification will be mandatory.
2. Without document verification, the admission of the candidate will not be valid.
3. TC, MIGRATION and Gap certificates will have to be submitted in original. Photocopy will not be valid.
4. If the candidate wants to cancel the admission, then for this he will have to make an application to the Registrar, P.K.University, within 15 days from admission. Admission will be canceled on completion of process.
5. In case of cancellation of admission by a candidate, any admission fee/fees paid by him/her will not be refunded.
6. If a student wants to change his course or branch, then he can apply for it till 15 days of admission.
7. Candidate must have at least 75% attendance.
8. While taking admission, the candidate will have to enter his/her mobile number, Whats-App number, and father's mobile number. It is very important to fill the E-mail Id
9. If the candidate changes his mobile number/ E-mail Id for some reason after a few days of admission, then it will be the responsibility of the candidate to present his mobile number in writing to the Head of Department and Admission Office in the university.
10. The University reserves the right to deny admission to any candidate/applicant who seeks admission to any course of study, who is found to be indulging in any criminal, illegal or anti-social activities and whose presence is within the University premises. It will be detrimental to the peaceful atmosphere in the university.
11. A candidate whose qualifying examination is not recognized by a recognized Board/University will not be eligible for admission. All such applications/admissions are cancelled/cancelled
12. The eligibility rules specified for each course will be strictly followed and will not be relaxed under any circumstances. The candidate should satisfy himself that he fulfills the prescribed eligibility requirements for admission to the concerned course of study
13. If the candidate is found misbehaving with anyone or indulging in any wrongdoing. If so, then the university administration will take the strictest action against that candidate.
14. RAGGING is banned in the University campus and is a punishable offence as per P.K.University Student's Conduct and Discipline Rule. It is mandatory the student shall not take part in any form of ragging.
15. Any dispute with regard to any matter relating to admission in the University shall be subject to the jurisdiction of Local Courts at Shivpuri ,(M.P.) and High Court of Judicature at, Gwalior, Madhya Pradesh only.
