(As per NEP 2020 :-52(A) & MPPURC MP)

- The Board reviewed and discussed the draft scheme and syllabi for semesters III & IV.
- Feedback included:
 - Blended learning and continuous internal evaluation (CIE) methods.
- **Resolution:** Approved, pending formatting edits and minor structural updates.

5. Approval of MCA Scheme & Syllabus (3rd , 4th Semesters – 2nd Year)

- Proposed curriculum (Sem III–IV) for MCA program was presented.
- Discussion included:
 - Specialization tracks, elective choices.
 - Industry readiness via capstone projects.
- **Resolution:** Approved with suggestions to strengthen project-based assessment components.

6. Approval of Part-Time Ph.D. Program (All Specializations)

- Proposal for launching a **Part-Time Ph.D. Program** in all specializations within the Faculty was presented.
- Key components discussed:
 - Entry criteria, course requirements, supervisor workload, duration norms.
 - NEP-aligned flexibility and research milestones.
- **Resolution:** Approved with the directive to draft accompanying guidelines/manual and report back in the next meeting.

- A miscellaneous item/session for future BOS scheduling, digital library needs, or resource allocation may be discussed here.
- No new matters were proposed
- **Resolution:** No additional items were raised. Meeting concluded.
